Aviation Medical - <i>It is recommend that this be organised prior to commencement of training. In some cases your home country may have a doctor approved by CASA to conduct the medical, Training can commence without a medical.</i>	\$650
Overseas Student Health Cover (price per year or part thereof) <i>This is an approximate price as providers have varying fees</i>	\$450

ASIC (Aviation Security Identity Card)	\$220
CASA Exam fees <i>Allow a budget of approximately \$160 for the PPL exam, \$150 for each CPL theory exam (there are 7 exams) and \$160 for the Instrument Rating theory exam.</i>	\$1200 - \$1400

CASA flight test fees (\$600 each for PPL, CPL and instrument Rating and \$300 for multi engine test)
Landing fees – Air services charges. Approximately \$2000 for Diploma of Aviation (CPL) and an additional \$500 if also conducting the Diploma of Aviation (Instrument Rating).
CASA licence issue fees \$200 - \$300
