CASA Exam fees <i>Allow a budget of approximately \$165 for the RPL exam, and approximately \$160 for each CPL theory exam (there are 7 exams)</i> Note: An invoice for all your exam fees will be issued at the completion of the RPL phase of your training. We will then book and pay for your CASA exams as required.	\$1300 -\$1500

Tower fees - Landing fees – Air services charges (approximate fees) Allow approximately a further \$650 if also undertaking the Diploma of Aviation (Instrument Rating)	\$2200 (CPL) \$650 (IR)

Prior to your RPL flight test you need to undertake a CASA English Language Proficiency Assessment Students with a high level of English will undertake a Level 6 Assessment at the school whilst other students will undertake a Level 4 Assessment at an external ASPEQ test center.
